

RELEASE OF LIABILITY - READ BEFORE SIGNING

I, _____, the undersigned,

in consideration of being allowed to participate in any way in the **Chesuncook Lake House, Chesuncook Boom House, Chesuncook, LLC,**

It's related events and activities, acknowledge, appreciate, and agree that:

1. The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular skills, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist. The same elements that contribute to the unique character of activity can be causes of loss or damage to equipment, accidental injury to participants, illness, or in extreme cases, permanent injury or death; and,

I acknowledge that canoeing and kayaking on rivers, coastal waters, and lakes entails known and unanticipated risks which could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity. Whitewater rapids, wave/wind action, tidal currents, or fog may be encountered. Canoes and kayaks can capsize and/or fill with water; one may be washed out of the boat. You can slip or fall during a hike resulting in damage to equipment or personal injury. Accidents can occur getting in and out of canoes and kayaks. Canoes and kayaks are slippery when wet. Exposure to the natural elements can be uncomfortable and/or harmful. You should be aware that this exposure could cause sunburn, dehydration, heat exhaustion, heat stroke, and heat cramps. Also prolonged exposure to cold water can result in hypothermia and in extreme cases death. Accidental drowning is also a possibility. I understand that the use and proper wearing of a personal floatation device at all times is strongly recommended; and,

2. I understand and acknowledge the above list is not complete or exhaustive, and that other risks, known or unknown, identifies or unidentified, anticipated or unanticipated may also result in bodily injury, death, illness, or damage to myself, to my property or to others. I expressly accept those risks not specifically listed above as well. My participation in this activity is purely voluntary, no one is forcing me to participate, and I elect to participate in spite of the risks; and,

3. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, **EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES** or others, and assume full responsibility for my participation; and,

4. I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the Company immediately; and,

5. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, **HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS Chesuncook, LLC**, their officers, officials, agents and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used for the activity ("Releasees"), **WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH**, or loss or damage to person or property associated with my presence or participation, **WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE**, to the fullest

extent permitted by law; and,

6. This agreement shall be governed in all respects by the laws of the State of Maine; and,

7. Should it become necessary for Chesuncook, LLC, or someone on Chesuncook, LLC's behalf, to incur attorney's fees and costs regarding my participation

in this activity, I agree to pay SCK reasonable costs and attorney's fees if Chesuncook LLC is not held liable for my injuries or damages.

8. A Personal Flotation Device (PDF) is to be worn at all time by anyone in a water craft rented from Chesuncook, LLC., when watercraft is in or near the water.

9. The Renter will adhere to all current State of Maine boating laws when operating a watercraft rented from Chesuncook,LLC.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
